

Privacy Policy – Australian Lottery Retailer

Introduction

This Privacy Policy describes how we collect, use, disclose, and protect your personal information when you interact with our lottery retail services in Australia. We are committed to ensuring your privacy is protected in accordance with the Privacy Act 1988 (Cth) and the Australian Privacy Principles (APPs). By using our services, you agree to the terms of this Privacy Policy.

What Information We Collect

We may collect the following types of personal information: full name, address, date of birth, email address, phone number, payment details, and identification documents for age verification. We may also collect non-personal information such as IP addresses, device type, browser information, location data, and browsing behaviour on our website.

How We Collect Information

Personal information is collected through online forms, direct communication, payment transactions, account registration, and automated technologies such as cookies and analytics services. We may also collect information from third-party sources with your consent.

Use of Your Information

We use your personal information to: verify your identity, process lottery ticket purchases, manage your account, send promotional emails, provide customer support, ensure compliance with legal obligations, and improve our services. Your information helps us maintain the integrity of our lottery operations and provide a secure environment for users.

Disclosure of Your Information

We do not sell or rent your personal information. However, we may disclose it to: regulatory bodies, our service providers, legal advisers, and law enforcement agencies if required by law. All third parties handling your data must comply with strict confidentiality obligations.

Data Security

We take reasonable steps to protect your information using industry-standard security measures such as SSL encryption, firewalls, secure servers, and data access restrictions. Despite our efforts, no system is entirely secure, and you acknowledge this risk.

Cookies and Tracking Technologies

Our website uses cookies and similar technologies to enhance your browsing experience, analyze traffic, and deliver targeted advertisements. By continuing to use our site, you consent to our use of cookies as outlined in this policy.
